A part of Lots 27 and 28 in Block 1 in 2nd Lake Addition to the City of Hammond, Indiana, the plat of which addition is recorded in Plat Book 18, page 12, in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the southwest corner of said Lot 28; thence North 0 degrees 28 minutes 31 seconds East 3.048 meters (10.00 feet) along the west line of said Lot 28 to the northwest corner of the grantors' land; thence South 89 degrees 06 minutes 48 seconds East 2.608 meters (8.56 feet) along the north line of the grantors' land; thence South 0 degrees 28 minutes 31 seconds West 6.231 meters (20.44 feet); thence North 89 degrees 31 minutes 29 seconds West 2.608 meters (8.56 feet) to the west line of said Lot 27; thence North 0 degrees 28 minutes 31 seconds East 3.201 meters (10.50 feet) along said west line to the point of beginning and containing 16.3 square meters (175 square feet), more or less.
