Upon termination, the Surety shall be relieved from any liability for any subsequent acts or omissions of the Principal.

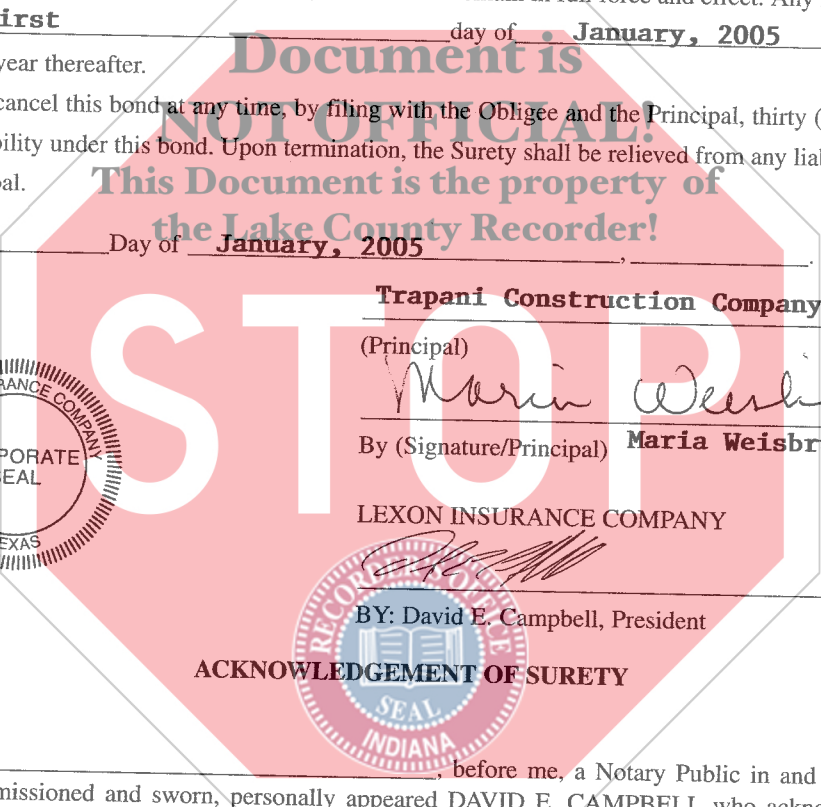
