

2. **Application of Payments or Proceeds.** Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this instrument, and then to reduce the principal balance of the amounts due under this instrument.

Payments are deemed received by Lender when received at the location designated in the Note or at other locations as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may return any payment or partial payment if the payment or partial payments are insufficient to bring the Loan current. Lender may accept any payment or partial payment in its discretion to bring the Loan current, without waiver of any rights hereunder or preclusive to its rights to refuse such payment or partial payment in the future, but Lender is not obliged to apply such payments at the time such payments are accepted. 


