5. That the purpose of this affidavit is to induce the **Lake County Auditor** to show the transfer of such property on his records.

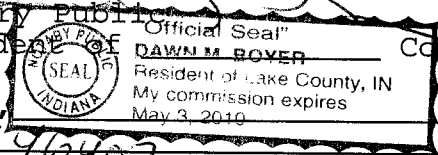
