KNOW ALL MEN BY THESE PRESENTS:

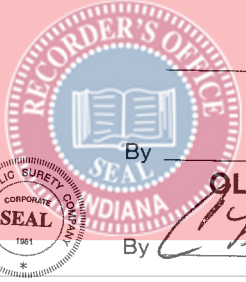
WHEREAS, the said Principal has applied to said Obligee for a license to or permit as a Residential Roofing


- RESOLVED FURTHER, that any bond, undertaking, recognizance, or suretyship obligation shall be valid and binding upon the Company

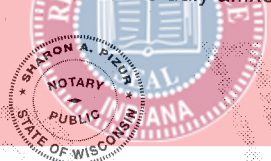


