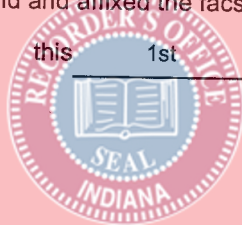
Extract from the By-Laws of **AMERICAN STATES INSURANCE COMPANY**:

"Article 8.
