DEED IN TRUST

THIS INDENTURE WITNESSETH, that the Grantor, EMMA G. This conveyance is made upon the express understanding and condition that neither PEOPLES BANK, SB, jointly or individually, as Trustee, nor its successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything they or their agents or attorneys may do or omit to do in or about the real estate or under the provisions of this Deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all such liability being hereby expressly waived and released.
