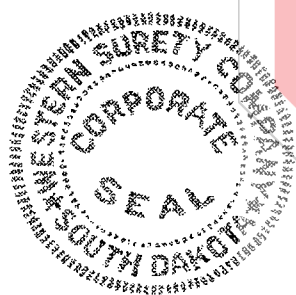

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

State of South Dakota, its regularly elected Senior Vice President

as Attorney-in-Fact with full power and authority hereby conferred upon him to sign, execute, acknowledge and deliver for and on his behalf as Surety and as its act and deed, all of the following classes of documents to-wit:
