and ending on the 24TH day of JANUARY, 2005.

This bond may be terminated at any time by the Surety upon sending notice in writing by First Class U.S. Mail  
to the Obligee and to the Principal at the address last known to the Surety, and at the expiration of thirty-five (35)  
days from the mailing of notice or as soon thereafter as permitted by applicable law, whichever is later, this bond  
shall terminate and the Surety shall be relieved from any liability for any subsequent acts or omissions of the  
Principal. Regardless of the number of years this bond shall continue in force, the number of claims made against  
this bond, and the number of premiums which shall be payable or paid, the Surety's total limit of liability shall not  
be cumulative from year to year or period to period, and in no event shall the Surety's total liability for all claims  
exceed the amount set forth above. Any revision of the bond amount shall not be cumulative.

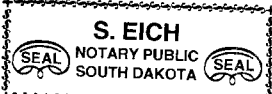

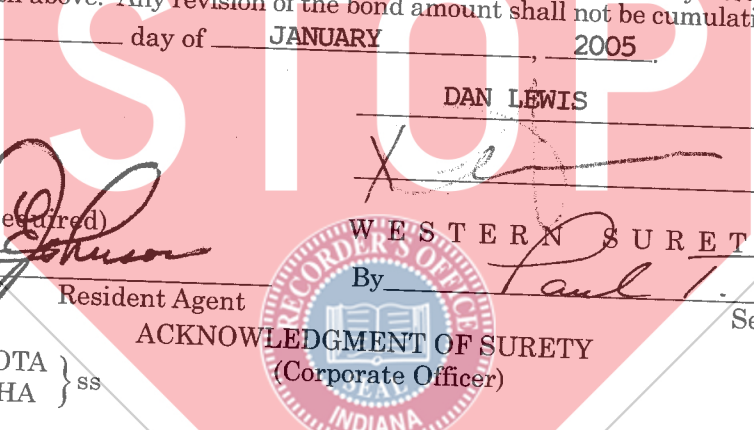

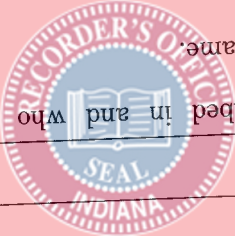
