AFFIDAVIT OF SURVIVORSHIP

Rosemarie Haberlin, being first duly sworn upon her oath, deposes and says:

1. That she is the wife of Vern Haberlin, that Vern Haberlin and Rosemarie Haberlin were married on the date that they acquired title as husband and wife as tenants by the entireties to certain Real Estate in LAKE County, Indiana, To-Wit:

**Lots 6 and 7 in Block 3 in Nelson's Oak Grove Addition in Cedar Lake, as per plat thereof, in the office of the Recorder of Lake County, Indiana.(Key # 24-89-6 & 7)**

**Part of Government Lot 2 in the fractional South 1/2 of the North 1/2 of Section 34, Township 34 North, Range 9, West of the Principle Meridian, in Lake County, Indiana, said part being a strip of land 100 feet long measured at right angles and lying Easterly of the Easterly lot lines of Lots 6 & 7 in Block 3 in Nelson's Oak Grove Addition to Cedar Lake, as per plat thereof, recorded in Plat Book 16, page 18, and bounded on the North by the North line of said Lot 6 extended East, and on the South by the South line of said Lot 7 if extended East. (Key # 24-19-36)**

2. The marital relationship which existed between Vern Habelrin and Rosemarie Haberlin continued unbroken from the time they so acquired title to said real estate until the death of Vern Haberlin on 10-10-02, at which time Rosemarie Haberlin acquired title.

3. That the gross value of the estate of the said Vern Haberlin, deceased, taking into consideration in the evaluation thereof, the value of all his gifts in contemplation of death, including all gifts made by him in the three years next preceding his death, together with the value of all of his investments in joint properties and tenants by the entirety, including the real estate in the above-described deed, plus the proceeds of all insurance on his life, did not equal or exceed the sum required to necessitate the filing of a federal estate tax return and that as a consequence of which, his estate was not subject to federal estate tax.

4. That all debts, estate and inheritance taxes, funeral expenses, and expenses of the last illness of Vern Haberlin have been fully paid and satisfied.
