
The lien of said mortgage shall remain in full force and effect as to remainder of the real estate.

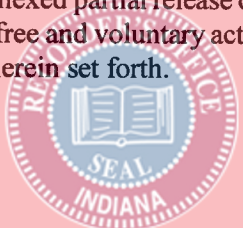


