Know all persons by these presents MICHAEL A. BROWN  
RECORDER

I, Helen P. Mavronicles, do make, constitute and appoint Janis Faye Dopp as my attorney-in-fact, in my name to have the power:

- a. to make, draw and endorse promissory notes, checks or bills of exchange and to waive demand, presentment, protest, notice of protest and notice of non-payment of all such instruments;
- b. to make and execute any and all contracts;
- c. to purchase, sell, dispose of, assign and pledge notes, stocks, bonds and securities and to exercise such voting rights as my ownership of any notes, stocks, bonds and securities may entitle me, either in person or by proxy;
- d. to represent me in all matters pertaining to the business of any corporation in which I may have any interest;
- e. to receive and to demand all sums of money, debts, dues, accounts, whatsoever which are now or shall hereafter become due or payable to me and to compromise or discharge the same;
- f. to margin for, contract concerning, buy, sell, mortgage and in any and every way and manner deal with personal property of any kind or nature;
- g. to execute instruments to effect the transfer of title to any motor vehicle owned by me;
- h. to prepare, execute and file all tax returns and to receive and negotiate all tax refund checks;
- i. to purchase, sell, mortgage, convey and lease any interest in real estate, wherever located, of which I may be owner now or hereafter;
- j. to transact any and all business for me of any kind of nature whatsoever and to do and perform each and every act and thing whatsoever requisite and necessary or proper to be done in all matters affecting my business or property, and with the same force and effect as I were personally present and acting for myself, including all powers granted in I.C. 30-5-5 Sections 2 through 19.

Furthermore, I hereby ratify and confirm all that my said attorney in fact or agent shall do by virtue hereof.

Further, this power of attorney shall be in full force and effect only from today's date until the occurrence of (1) my death; (2) the death of my said attorney; or (3) the revocation of this power of attorney by me by filing a written revocation in the Recorder's Office of the County at my legal domicile.

I further state that this Power of Attorney shall not be affected by my incompetence.

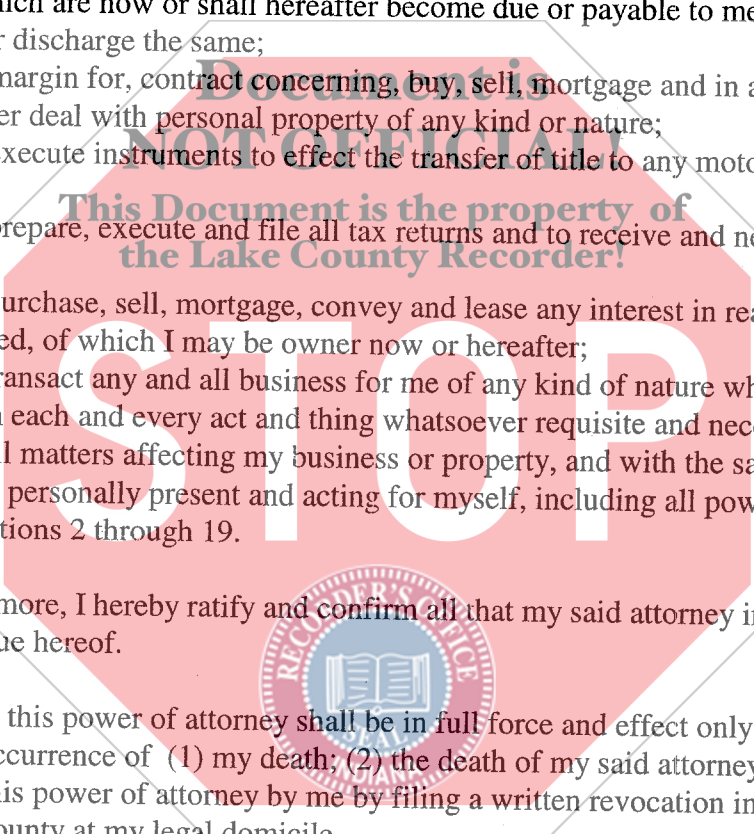

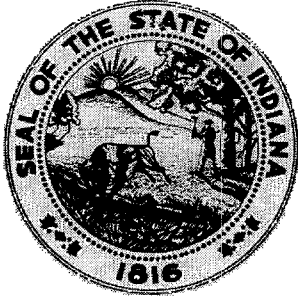
