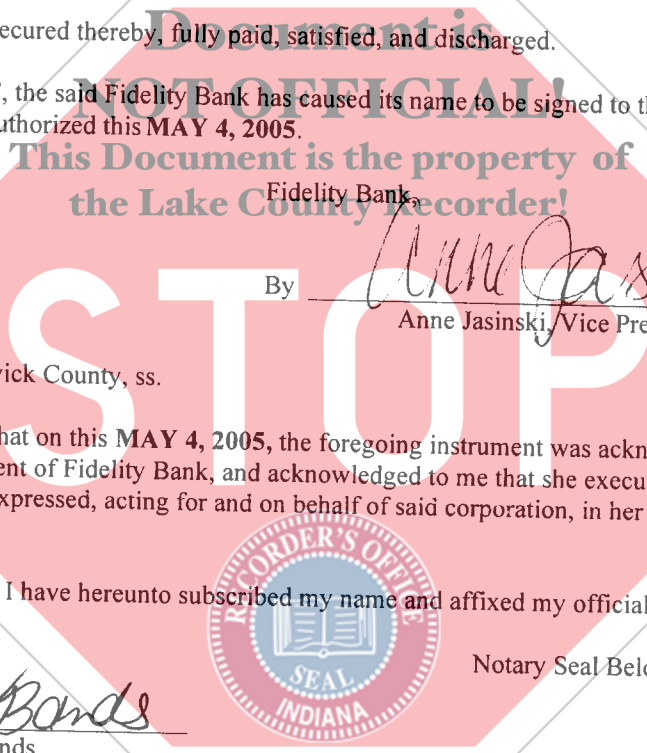

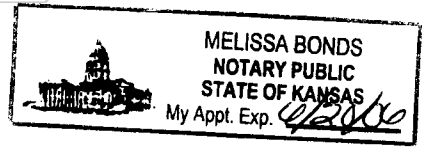

Legal Description

Part of Lot 5 and an undivided 1/20th interest in Outlot "A" in Luke's Addition to the City of Hobart, as per plat thereof, recorded in Plat Book 82 page 30, in the Office of the Recorder of Lake County, Indiana: Being more particularly described as follows: Beginning at the Northerly most corner of said Lot 5; thence along a curve concave to the Northeast, having a radius of 50.0 feet, an arc distance of 24.24 feet; thence South 60 degrees 46 minutes 03 seconds West, a distance of 29.45 feet; thence South 19 degrees 31 minutes 38 seconds West, a distance of 77.62 feet to point on the South line of said Lot 5; thence North 88 degrees 06 minutes 36 seconds West, along South line of Lot 5, a distance of 97.07 feet to the Southwest corner of said Lot 5; thence North 00 degrees 03 minutes 10 seconds West, along the West line of said Lot 5, a distance of 27.82 feet to the Southwest corner of Lot 6 in said Luke's Addition; thence North 60 degrees 46 minutes 03 seconds East, along Northerly line of said Lot 5, a distance of 151.58 feet, to the point of beginning, all in the City of Hobart, Lake County, Indiana.
