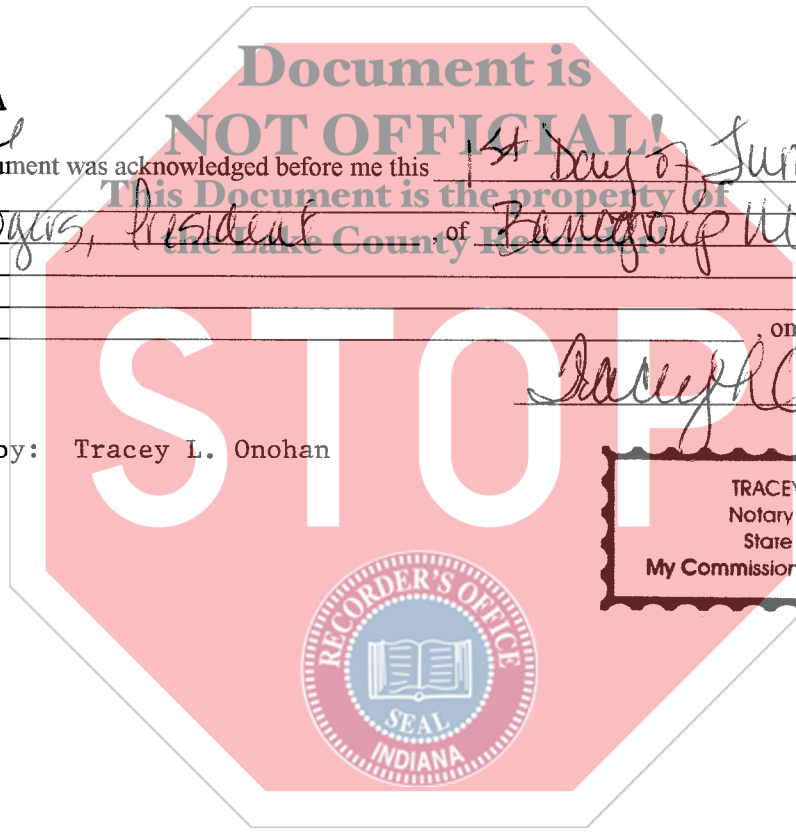

LEGAL DESCRIPTION

Part of Lot 106 in Briar Cove Subdivision Phase 4, in the Town of Schererville, as per plat thereof, recorded in Plat Book 95 page 4, in the Office of the Recorder of Lake County, Indiana, which part of said lot is described as follows:
Beginning at the Northwest corner of said Lot 106; thence Southerly, along the curved Westerly line thereof, an arc distance of 77.93 feet; thence North 85 degrees 28 minutes 58 seconds East, a distance of 130.00 feet to a point on the curved Easterly line of said Lot 106; thence Northerly, along said curved Easterly line, an arc distance of 51.91 feet to the Northeast corner of said Lot 106; thence Westerly, along the curved Northerly line thereof, an arc distance of 64.81 feet to a point of reverse curve; thence proceeding along the curved Northerly line of said Lot 106 an arc distance of 65.51 feet to the point of beginning.
