TRUSTEE'S DEED

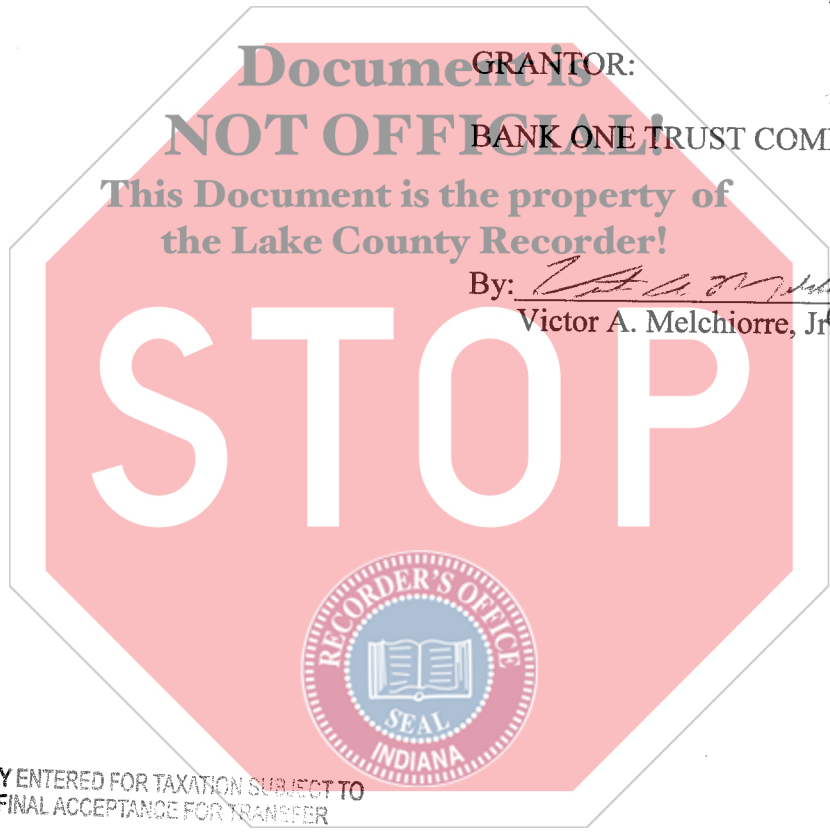
