**Convey and Warrant to**

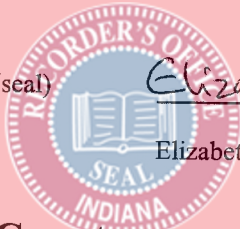

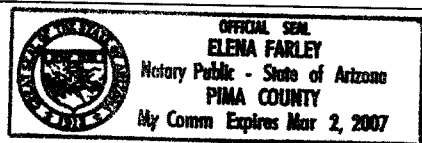
