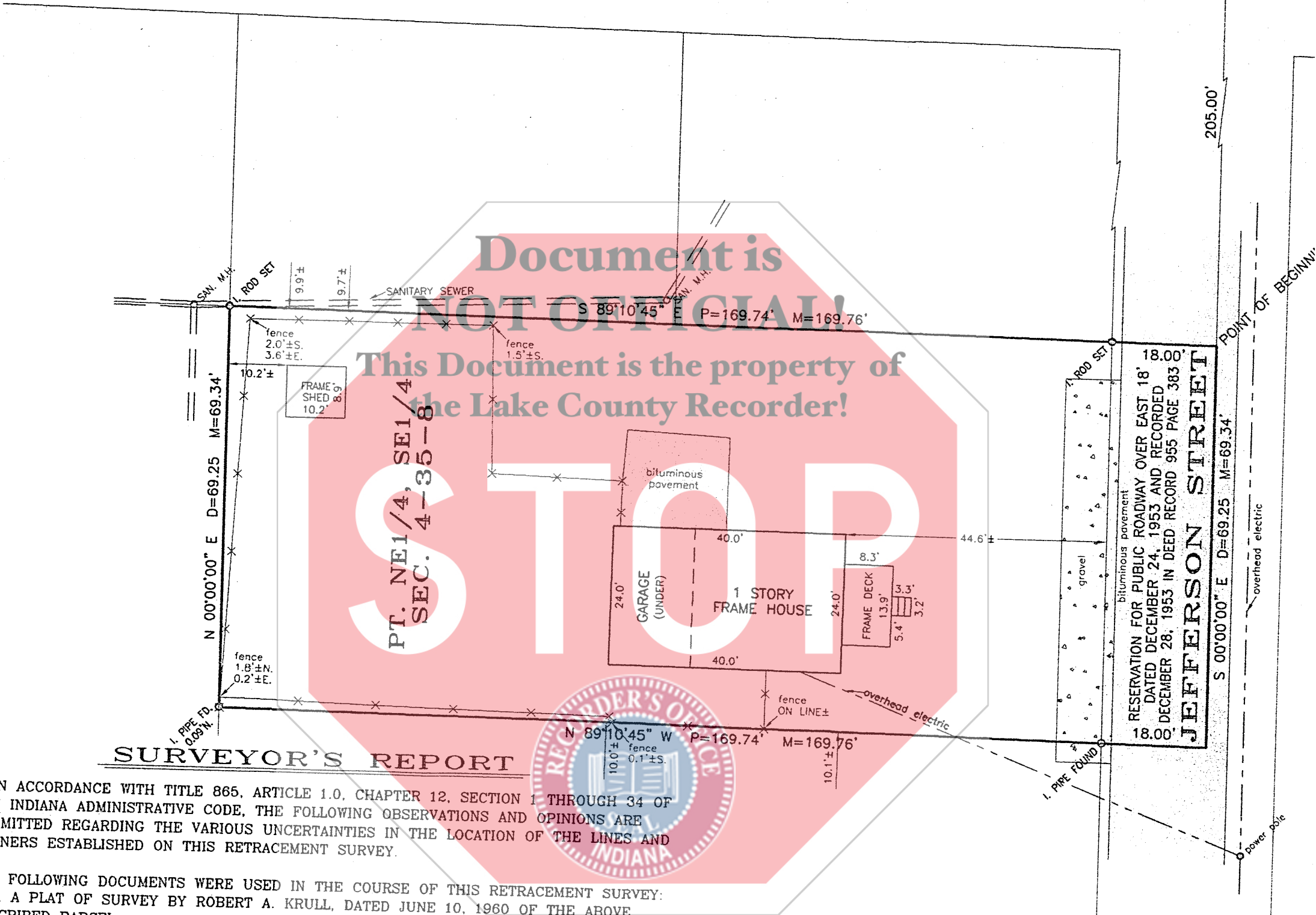

**SURVEYOR'S REPORT**

IN ACCORDANCE WITH TITLE 865, ARTICLE 1.0, CHAPTER 12, SECTION 1 THROUGH 34 OF THE INDIANA ADMINISTRATIVE CODE, THE FOLLOWING OBSERVATIONS AND OPINIONS ARE SUBMITTED REGARDING THE VARIOUS UNCERTAINTIES IN THE LOCATION OF THE LINES AND CORNERS ESTABLISHED ON THIS RETRACEMENT SURVEY.

THE FOLLOWING DOCUMENTS WERE USED IN THE COURSE OF THIS RETRACEMENT SURVEY:  
1. A PLAT OF SURVEY BY ROBERT A. KRULL, DATED JUNE 10, 1960 OF THE ABOVE DESCRIBED PARCEL.

THE FOLLOWING MONUMENTS WERE USED FOR THIS RETRACEMENT SURVEY:  
1. CORNERS FROM THE 1960 SURVEY WERE FOUND AND USED.

AVAILABILITY AND CONDITION OF REFERENCE MONUMENTS:  
THE REFERENCE MONUMENTS WERE IN GOOD CONDITION AND APPEARED UNDISTURBED AND WERE FOUND AT OR NEAR GRADE WITH THE EXCEPTION OF THE N.E. CORNER WHICH WAS FOUND 10" BELOW GRADE. A ROD WAS SET AT GRADE AT THIS CORNER.

UNCERTAINTIES RESULTING FROM OCCUPATION LINES:  
NO APPARENT UNCERTAINTIES IN POSSESSION WERE OBSERVED.

DISCREPANCIES DUE TO RECORD DESCRIPTIONS:  
NO APPARENT UNCERTAINTIES RESULTED FROM THE RECORD DESCRIPTIONS.

NOTE: BASIS OF BEARINGS WAS ASSUMED.

THE THEORETICAL UNCERTAINTY (DUE TO RANDOM ERRORS IN MEASUREMENT) OF THE SUBJECT TRACT ESTABLISHED THIS SURVEY IS WITHIN THE SPECIFICATIONS FOR A CLASS B SURVEY 0.25 FEET +/-, AS DEFINED IN IAC 865.

NOTE: According to FIRM Community-Panel 180138-0005-B dated October 15, 1981, the above described parcel is in Zone "C".
