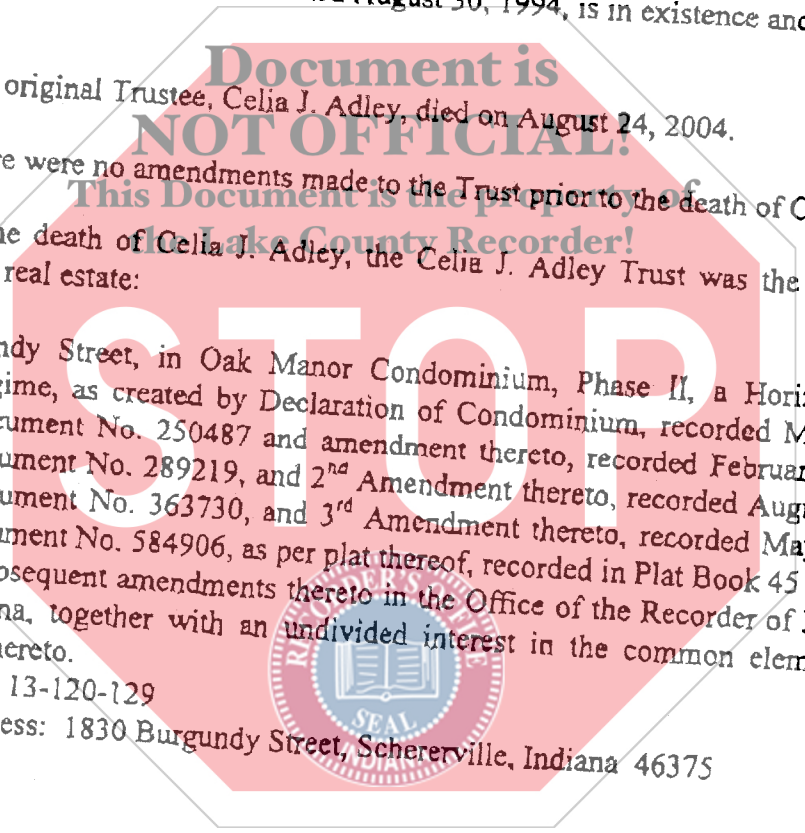
**AFFIDAVIT OF CERTIFICATION OF TRUST**

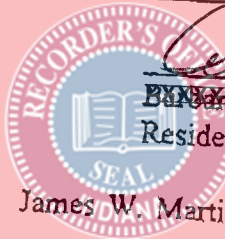
