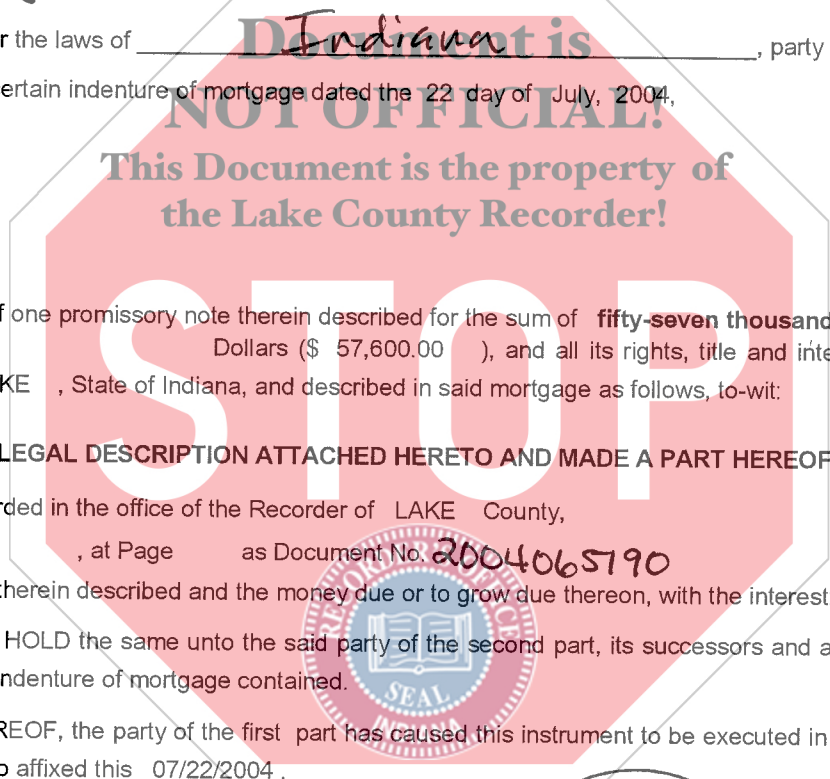
ASSIGNMENT OF MORTGAGE

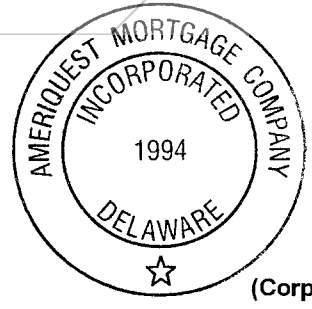

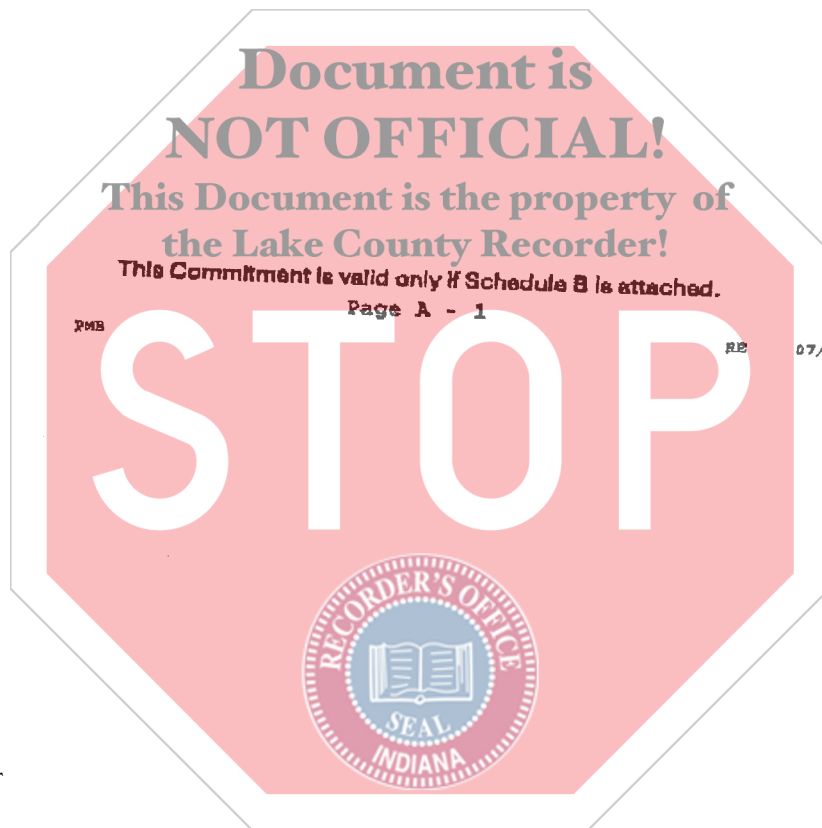
