THIS INDENTURE WITNESSETH, That Han S. Kwak

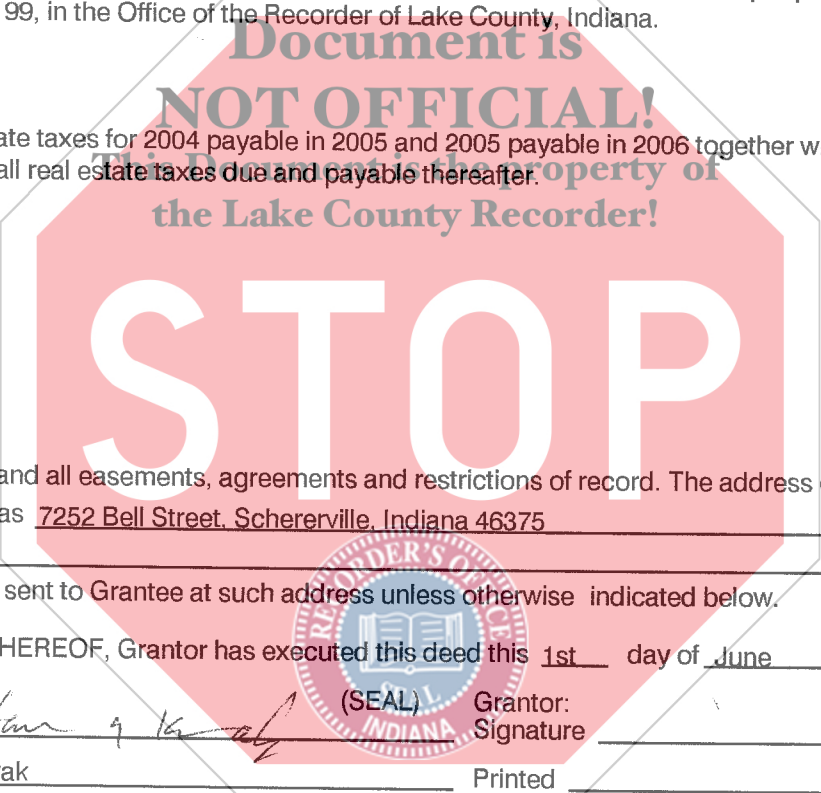

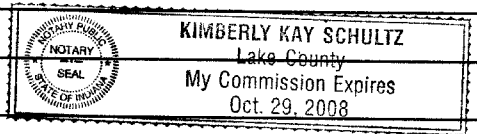
