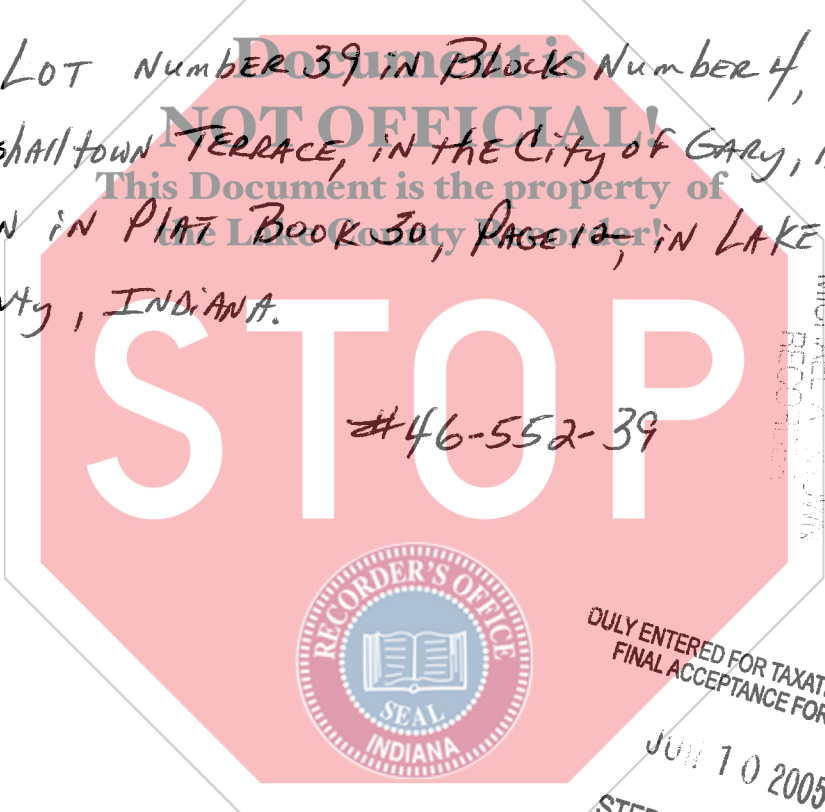


Quitclaim Deed
