- 1. Lot 14 is hereby added to the encumbrance of the Declaration pursuant to Article XX.E. of the Declaration. The Lot will be used for the construction of a Building containing eight (8) Units.  - c. The Unit located on the first floor in the northwest corner of the First Floor Unit Area of Building 14 is hereby designated Unit 1-C.
 - d. The Unit located on the first floor in the northeast corner of the First Floor Unit Area of Building 14 is hereby designated Unit 1-D.
 - e. The Unit located on the second floor in the southeast corner of the second floor of Building 14 is hereby designed Unit 2-A.
 - f. The Unit located on the second floor in the southwest corner of the second floor of Building 14 is hereby designed Unit 2-B.
 - g. The Unit located on the second floor in the northwest corner of the second floor of Building 14 is hereby designed Unit 2-C.
 - h. The Unit located on the second floor in the northeast corner of the second floor of Building 14 is hereby designed Unit 2-D.

The Units in Building 14 have been assigned the tax key numbers shown on Schedule A.

- 5. 


