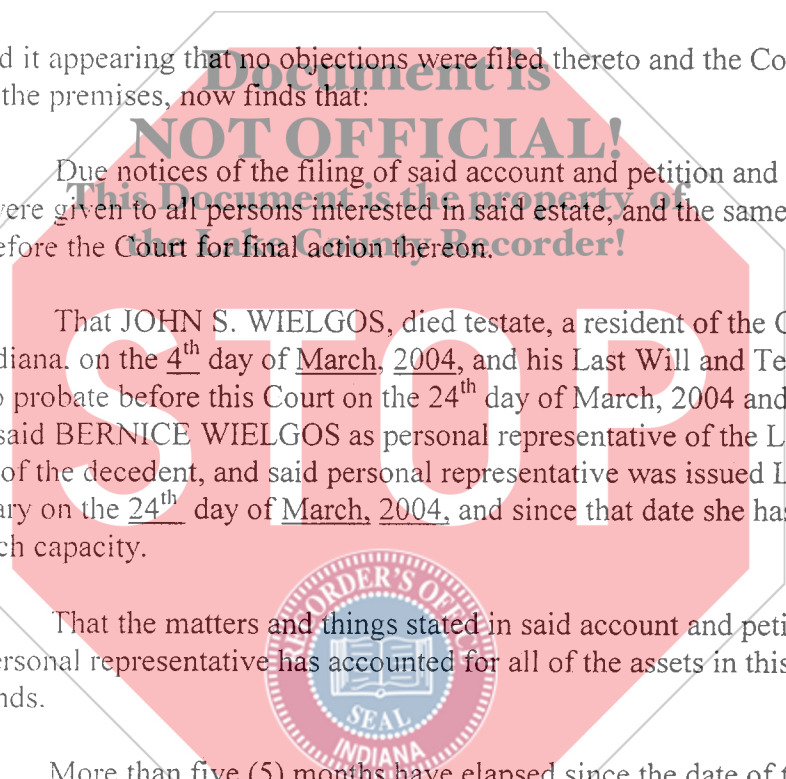
**ORDER APPROVING PERSONAL REPRESENTATIVE'S  
FINAL REPORT AND ACCOUNTING, PETITION TO  
ALLOW ACCOUNTING, PETITION FOR ORDER  
APPROVING DISTRIBUTION AND CLOSING ESTATE**

This cause came to be heard on the 25 day of May, 2005, upon the final account, petition to settle and allow account and for authority to distribute estate filed by BERNICE WIELGOS, as personal representative of the estate of JOHN S. WIELGOS, deceased, which account and petition are in the words and figures following-to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises, now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
2. That JOHN S. WIELGOS, died testate, a resident of the County of Lake, State of Indiana, on the 4<sup>th</sup> day of March, 2004, and his Last Will and Testament was duly admitted to probate before this Court on the 24<sup>th</sup> day of March, 2004 and this Court appointed said BERNICE WIELGOS as personal representative of the Last Will and Testament of the decedent, and said personal representative was issued Letters Testamentary on the 24<sup>th</sup> day of March, 2004, and since that date she has continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true and that said personal representative has accounted for all of the assets in this estate coming into her hands.
4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his personal representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5.
