WARRANTY DEED

THIS WARRANTY DEED, made the 18th day of May, 2005, by **FALCON HOLDINGS, LLC**, a Delaware limited liability company, with an address of 1200 Harger Road, Suite 200, Oakbrook, Illinois 60523, (the "**Grantor**"), for the benefit of **SPIRIT SPE PORTFOLIO 2004-6, LLC**, a Delaware limited liability company, with an address of 14631 North Scottsdale Road, Suite 200, Scottsdale, Arizona 85254-2711 (the "**Grantee**").

WITNESSETH:

Grantor, for itself and legal representatives, grant, bargain and agree to and with Grantee and its successors and assigns, that at the time of the ensembling and delivery of these presents, it is well seized of the Property above conveyed; has good, sure, perfect, absolute and indefeasible title, in law, in fee simple; has good right, full power and lawful authority to grant, bargain, sell and convey the same in the manner and form aforesaid; and that the same is free and clear from all former and other grants, bargains, sales, liens, taxes, assessments, encumbrances and restrictions of whatever kind or nature whatsoever, except covenants, conditions and restrictions of record as of the date hereof.

GRANTOR shall and will WARRANT and FOREVER DEFEND the above-conveyed Property in the quiet and peaceable possession of Grantee and its successors and assigns, against all and every person or persons lawfully claiming the whole or any part thereof.

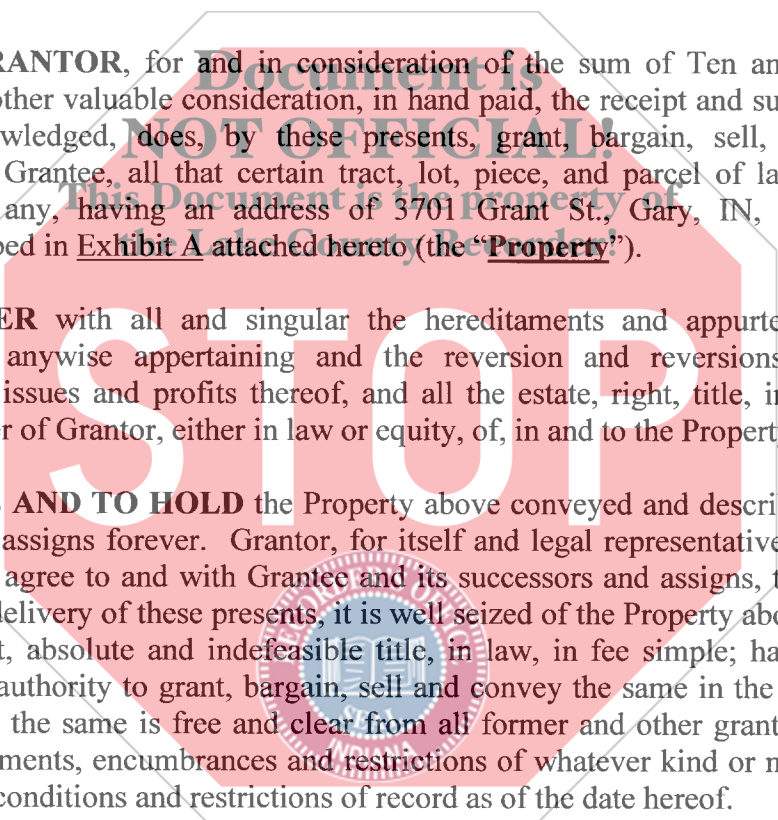
