**MEMORANDUM OF AMENDMENT OF THE

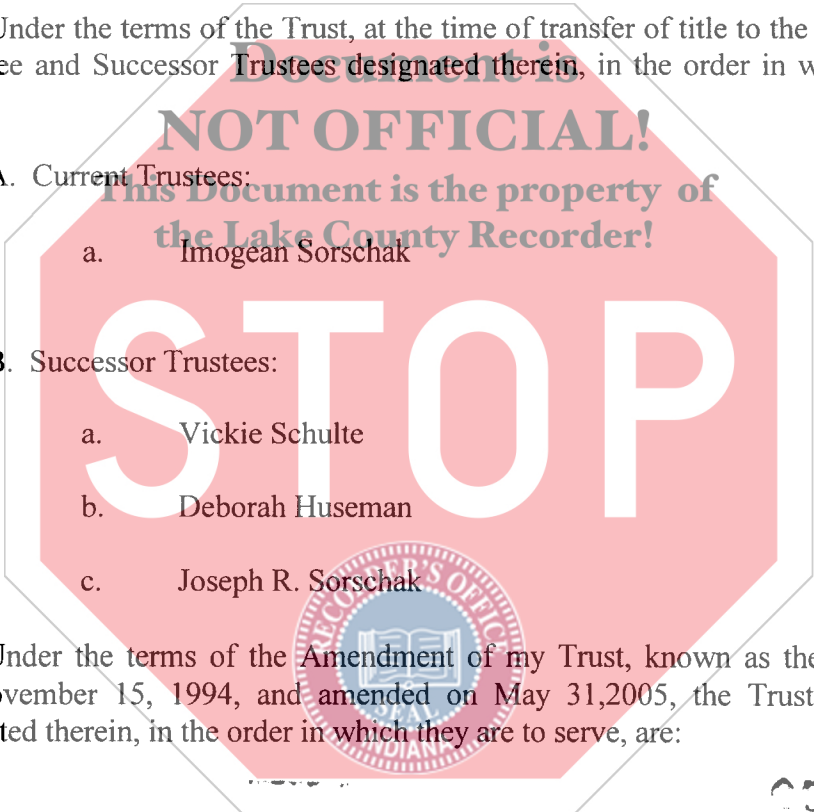
