

Part of Lot 4 in Springvale Farms, Court K, in the Town of Schererville, as per plat thereof, recorded in Plat Book 61 page 29 and corrected by Certificate recorded January 7, 1987 as Document No. 895417 in the Office of the Recorder of Lake County, Indiana, described as follows: Commencing at the Northwest corner of said Lot 4; thence South 05 degrees 39 minutes 00 seconds East, 47.28 feet; thence South 23 degrees 39 minutes 00 seconds East 39.46 feet to the point of beginning of this described parcel; thence continuing South 23 degrees 39 minutes 00 seconds East 32.66 feet; thence North 63 degrees 45 minutes 19 seconds East, 92.34 feet; more or less to the Easterly line of said Lot 4; thence Northwesterly along a curve to the right with a radius of 44.91 feet for a distance of 12.89 feet; thence North 26 degrees 18 minutes 14 seconds West, 19.91 feet; thence South 63 degrees 45 minutes 19 seconds West 88.99 feet, more or less to the point of beginning, commonly known as Unit 4-2, 1969 Aspen Court.
