

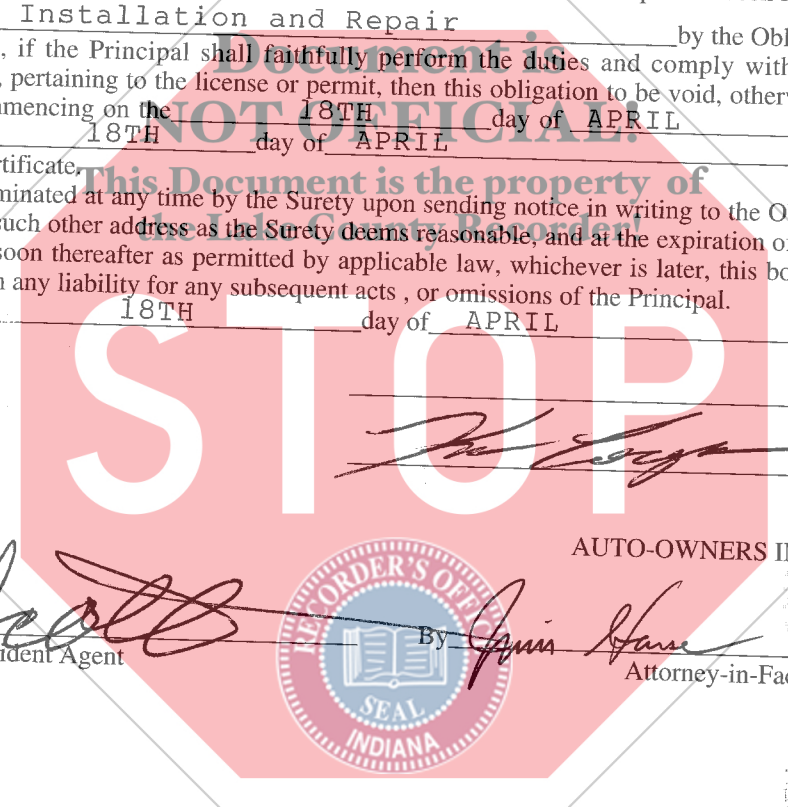

POWER OF ATTORNEY

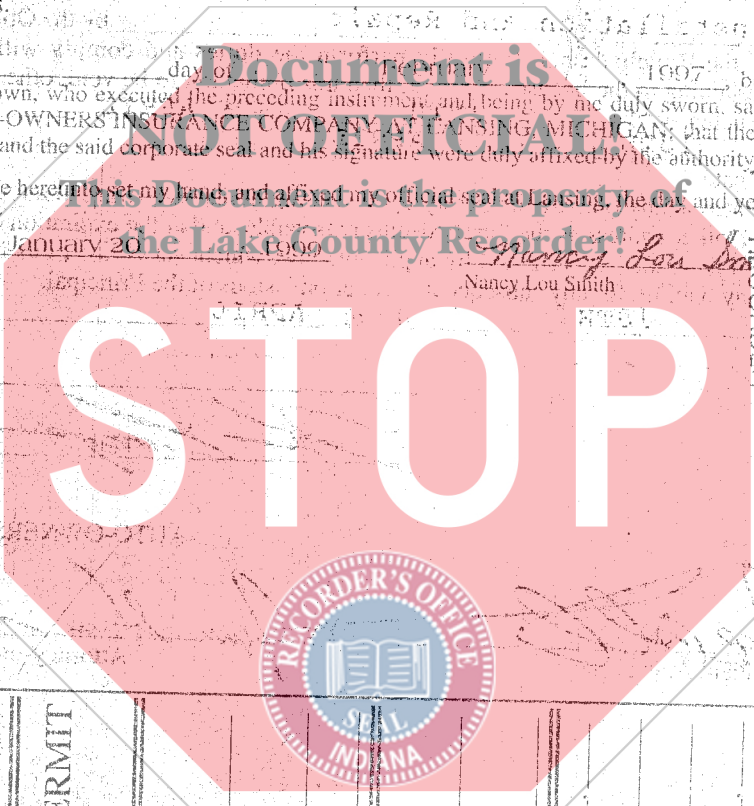
