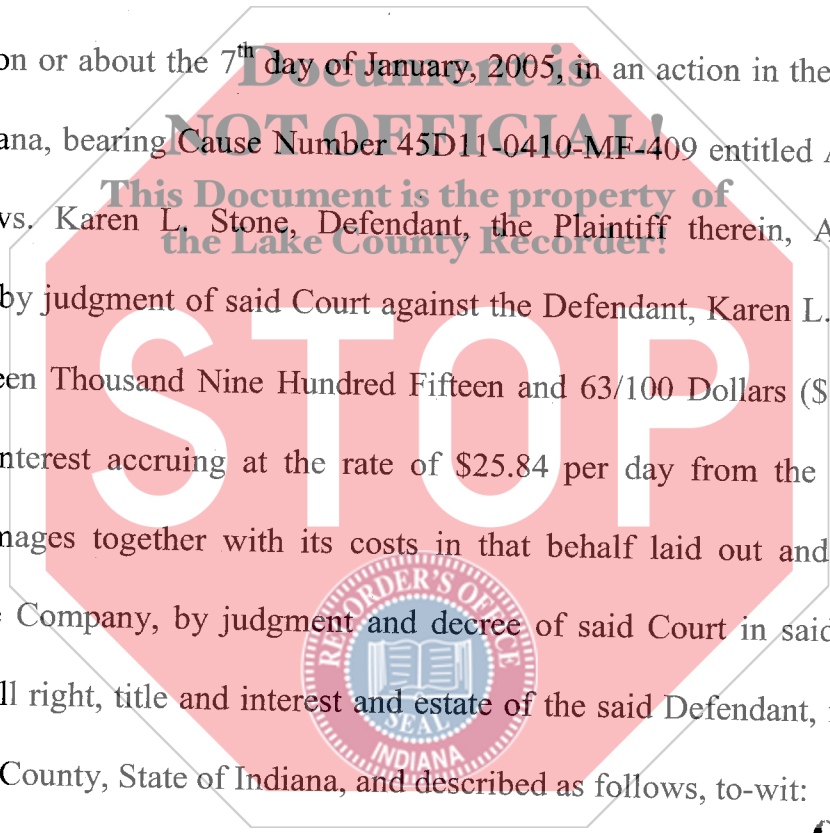

SHERIFF'S DEED ON DECREE

This indenture made this 6th day of May, 2005, by and between **ROGELIO "ROY" DOMINGUEZ**, Sheriff of Lake County, Indiana, as First Party, and **AMERIQUEST MORTGAGE COMPANY**, as Second Party.

WITNESSETH:

WHEREAS, on or about the 7th day of January, 2005, in an action in the Lake Superior Court of Lake County, Indiana, bearing Cause Number 45D11-0410-MF-409 entitled Ameriquest Mortgage Company, Plaintiff vs. Karen L. 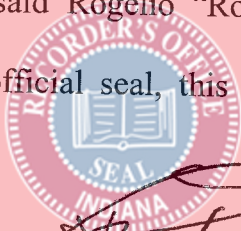
