Six (36), North, Range Nine (9) West of the Second Principal Meridian in Gary, Lake County, Indiana.

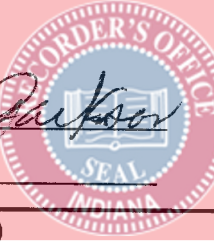
