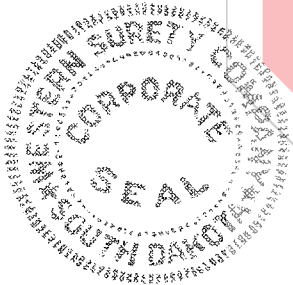

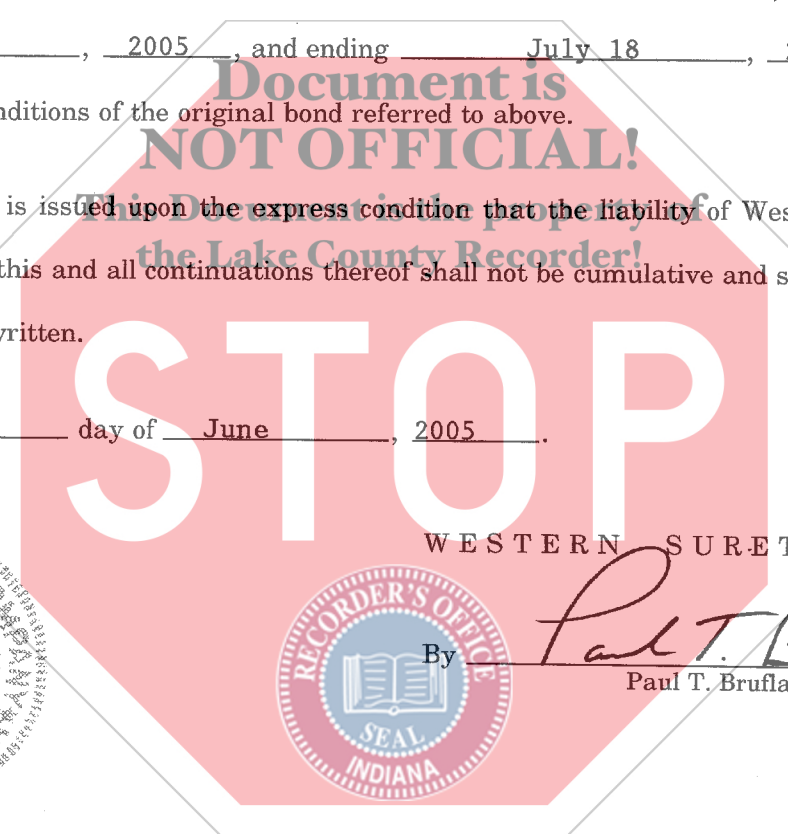

## POWER OF ATTORNEY

### KNOW ALL MEN BY THESE PRESENTS:
