PARCEL 1:

The North ½ of the Northeast 1/4 of Section 17, Township 35 North, Range 8 West of the Second Principal Meridian, in Lake County, Indiana, excepting therefrom the North 79 feet of the West 580 feet, and the South 830 feet of the West 1837 feet, and the right-of-way of the Chesapeake and Ohio Railway Company.

## PARCEL 2:
