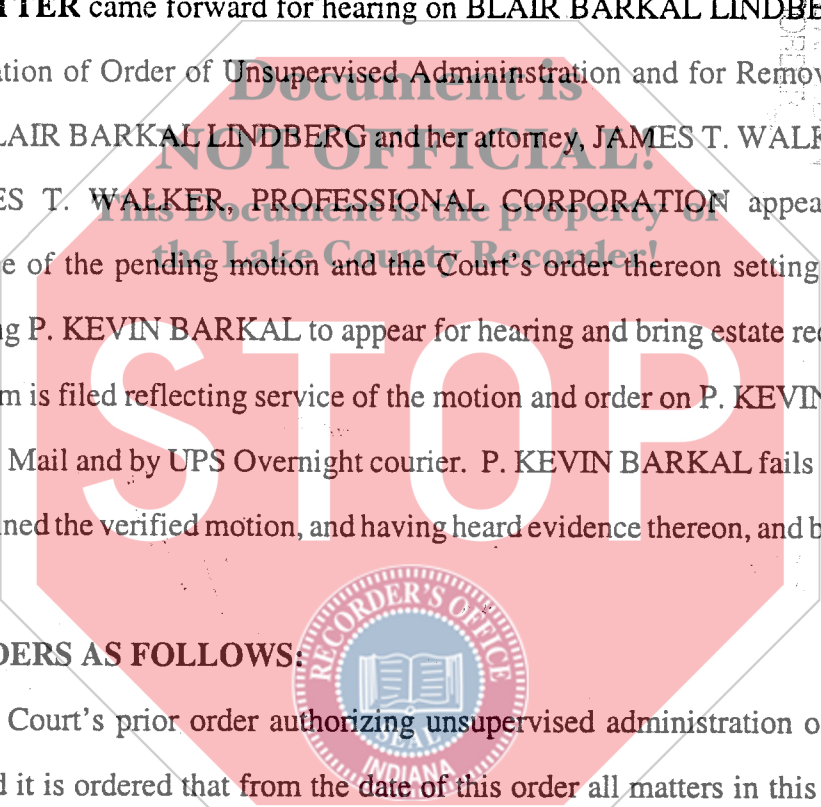

2. P. KEVIN BARKAL, previously appointed personal representative of this estate, is ordered removed as personal representative of decedent's estate instantler.

3. The Court appoints Bank Calumet to act as personal representative of decedent's estate. The Clerk shall issue supervised letters of administration to Bank Calumet upon its filing of acceptance and oath. Bank Calumet shall not be required to post bond.

4. The Court orders P. KEVIN BARKAL

a.) to turn over all estate funds and all other assets of the estate to Bank Calumet to the attention of its Trust Department at its principal office at 5231 Hohman Avenue, Hammond, Indiana 46320, not later than June 10, 2005;

b.) to file an accounting with the Court in conformity with Indiana Code 29-1-16-3 and 29-1-16-4 not later than June 24, 2005; and

c.) to deliver to Bank Calumet not later than June 24, 2005, all records of the estate, including but not limited to all bank statements, all cancelled checks, all deposit records, all documents supporting receipt of estate funds or assets, all documents supporting disbursement of estate funds, and all other documents which constitute the records of the estate.
