**MEMORANDUM OF AMENDMENT**  
**OF LAND TRUST LTDVD-101, DATED MAY 19, 1997**

1. On June 13, 2005, I Amended the "Successor Trustees" Article of my Land Trust, known as LTDVD-101, "Trust", which was originally executed on May 19, 1997.

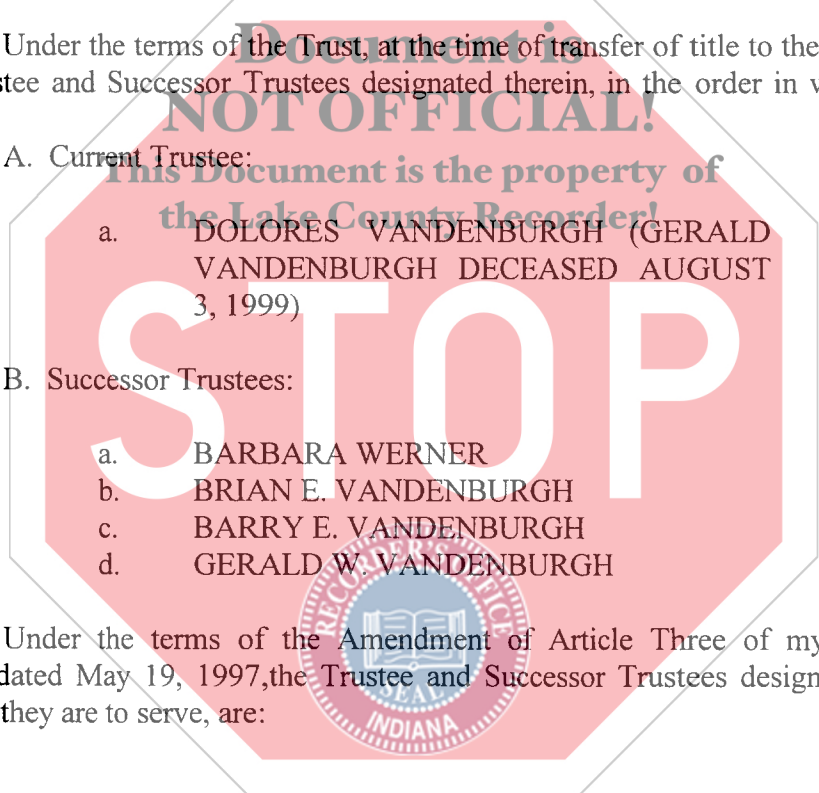
