Liability under this bond shall terminate as of the 28th day of June , 2006 , as to any acts subsequent thereto, unless said bond continues in force from year to year by the issuance of a continuation certificate signed by the surety. The Surety may cancel this bond at any time by filing with the Obligee thirty (30) days written notice of its desire to be relieved of liability. The Surety shall not be discharged from any liability already accrued under this bond, or which shall accrue hereunder before the expiration of the thirty day period.

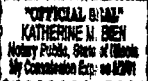
