- 7. GIFTS. Authority with respect to gift transactions pursuant to IC 30-5-5-9.
- 8. CLAIMS AND LITIGATION. Authority with respect to claims and litigation pursuant to IC 30-5-5-11.
- 9. FAMILY MAINTENANCE. Authority with respect to family maintenance pursuant to IC 30-5-5-12.

Authority with respect to all other matters pursuant to IC 30-5-5-19, which states that my attorney-in-fact has the authority to act as my "alter ego" with respect to all possible matters and affairs affecting my property which a principal may perform through an attorney-in-fact.

If protective proceedings are instituted on my behalf or a guardian is requested to act on my behalf, I name my attorney-in-fact to act on my behalf of as my guardian.
