## **DESCRIPTION OF COLLATERAL**

All equipment and machinery (excluding automotive), furniture and fixtures wherever located and whether in the possession of Debtor or any third party, intended or prepared for use in connection with the construction of, incorporation into or affixment to the Debtor's property or any building or improvement now or hereafter located on the Real Property.
- All and any proceeds or rights to proceeds arising out of any condemnation or exercise of
  right of eminent domain pertaining to the Debtor's property or any building or
  improvement now or hereafter located on the Real Property.

All proceeds of, substitutions and replacement for accessions to and products of any of the foregoing in whatever form, including, without limitations, cash, checks, drafts and other instruments for the payment of money (whether intended as payment or credit items), chattel paper, security agreements and documents of title.
