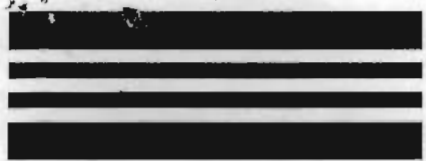

PARCEL 1: PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 20, TOWNSHIP 35 NORTH, RANGE 8 WEST OF THE SECOND PRINCIPAL MERIDIAN, IN LAKE COUNTY, INDIANA, DESCRIBED AS FOLLOWS: BEGINNING AT AN IRON PIPE ON THE SOUTH LINE OF THE NEWLY LOCATED LINCOLN HIGHWAY AND THE WEST LINE OF THE ABANDONED RIGHT OF WAY OF THE GARY AND SOUTHERN RAILWAY, SAID POINT BEING 70 FEET DISTANT WESTERLY OF THE EAST LINE OF THE SAID QUARTER QUARTER SECTION AFORESAID AND 145.45 FEET SOUTH OF THE NORTH LINE OF SAID QUARTER QUARTER SECTION; THENCE WESTERLY ALONG THE SOUTHERLY LINE OF THE NEWLY LOCATED LINCOLN HIGHWAY A DISTANCE OF 250 FEET TO AN IRON PIPE; THENCE SOUTH PARALLEL TO THE EAST LINE OF SAID QUARTER QUARTER SECTION, 350 FEET TO AN IRON PIPE; THENCE EASTERLY PARALLEL WITH AND 350 FEET SOUTHERLY OF THE SOUTH BOUNDARY OF THE NEWLY LOCATED LINCOLN HIGHWAY, 250 FEET TO AN IRON PIPE WHICH IS 70 FEET WEST OF THE EAST LINE OF SAID QUARTER QUARTER SECTION; THENCE NORTH ALONG THE WEST LINE OF THE ABANDONED RIGHT OF WAY OF THE GARY AND SOUTHERN RAILWAY, 350 FEET TO THE POINT OF BEGINNING.
