PROVIDED, HOWEVER:

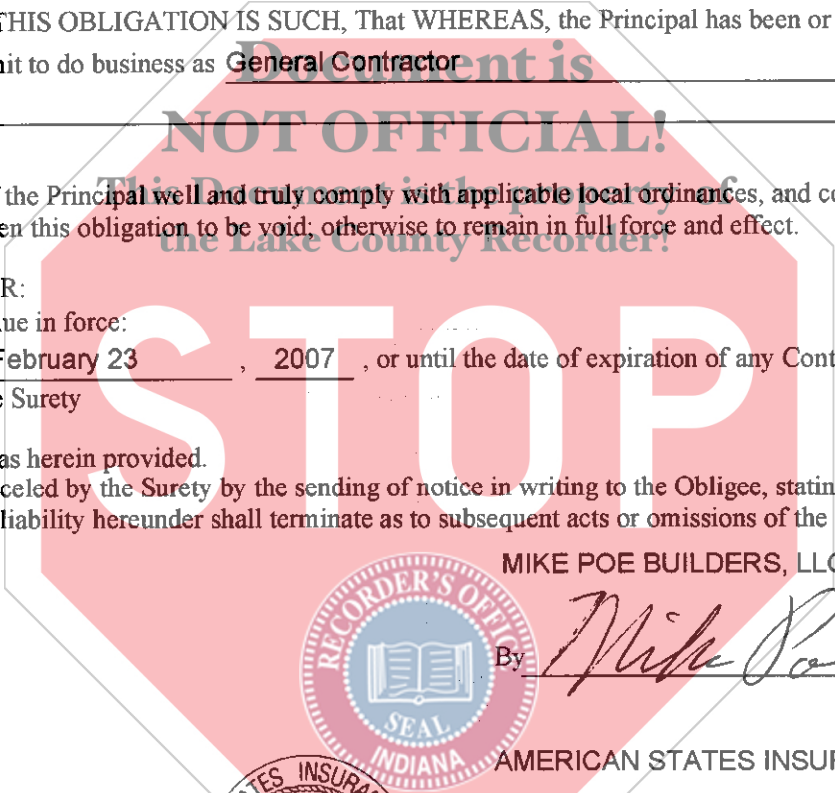
- 1. This bond shall continue in force:
