Subject to taxes for the year 2005 payable in 2006 and all taxes subsequent thereto.

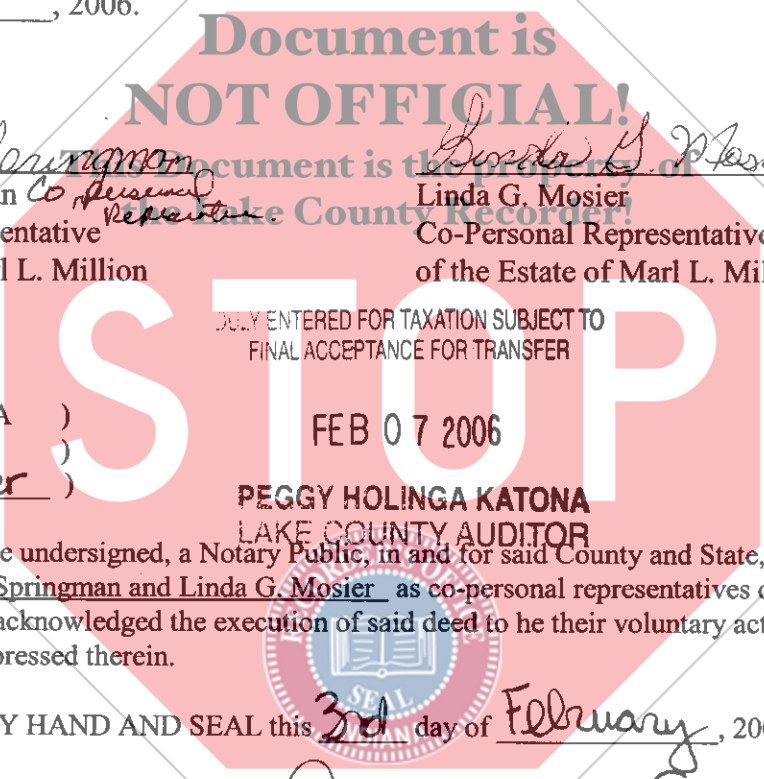

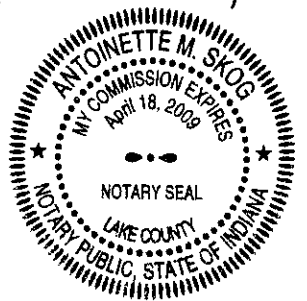
