East Chicago, Indiana

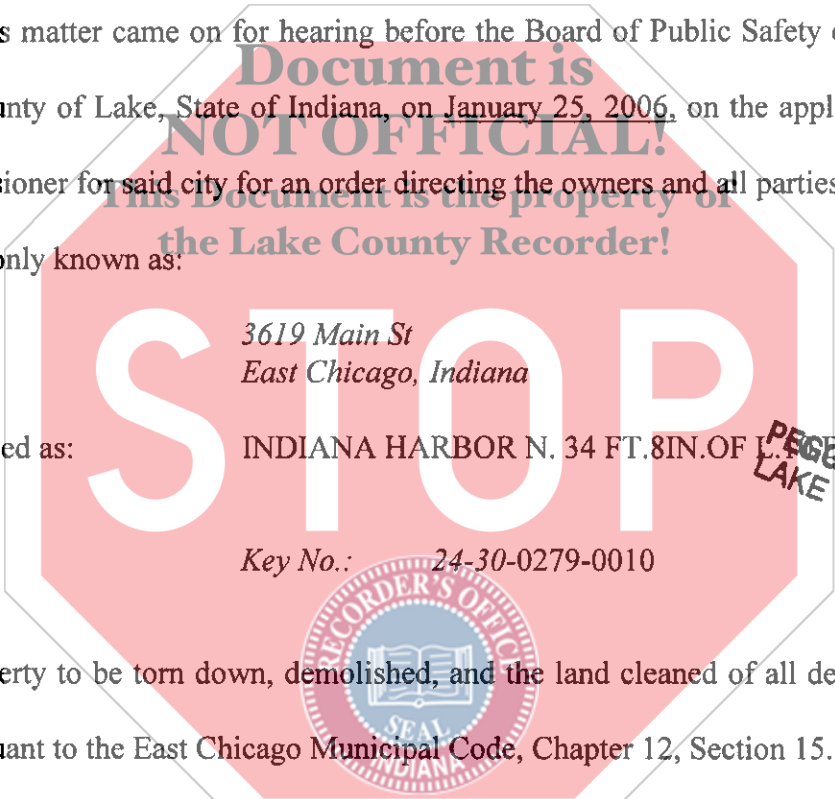
