WARRANTY DEED

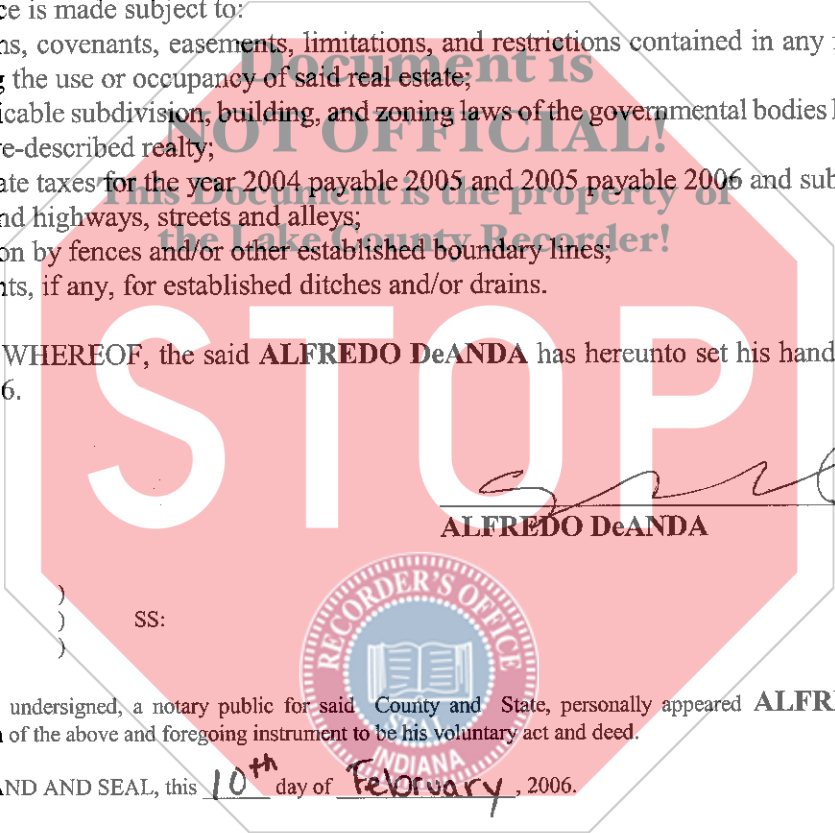

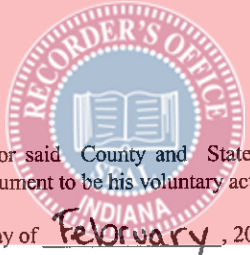

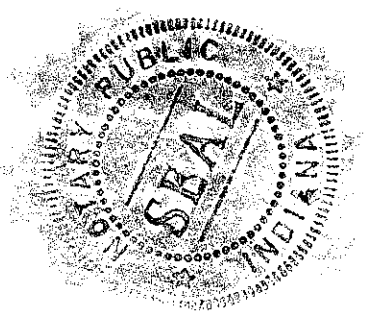
