AMENDMENT TO LEASE AGREEMENT

- 1. All provisions set forth in paragraph 10 and 15 of the Lease which run to the benefit of the Federal Housing Commissioner or under any mortgage insured by the Federal Housing Commissioner shall now run also to the benefit of Lender and to the mortgage securing the Loan as may hereafter be amended or modified.
- 2. Landlord agrees that the Lease may not be terminated by Tenant without the prior written consent of Lender.
- 3. Landlord represents to Lender that it is unaware of any default under the Lease as of the date hereof.
- 4. Landlord and Tenant agree that Lender shall be an express third party beneficiary of the terms and provisions of this Amendment to Lease Agreement and of the Lease.
