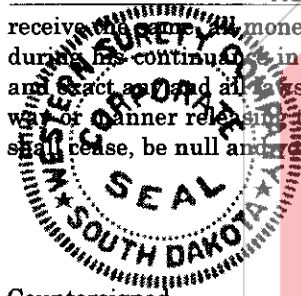

 shall cease, be null and void, otherwise to be and to remain in full force and virtue in law.



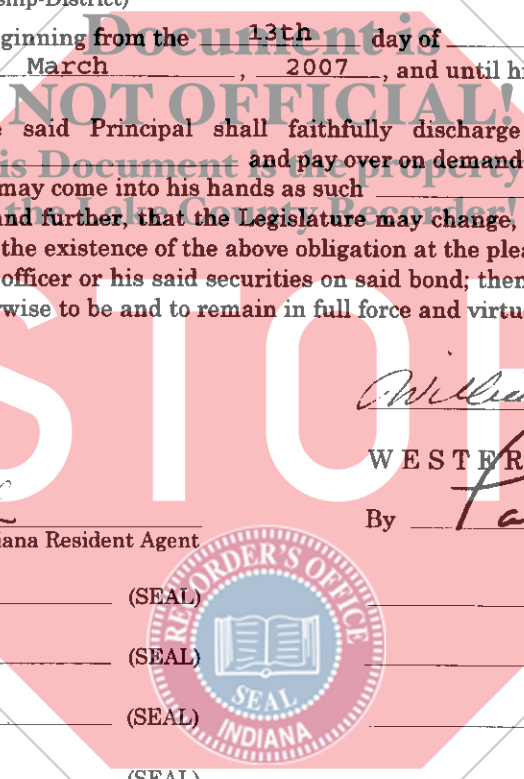

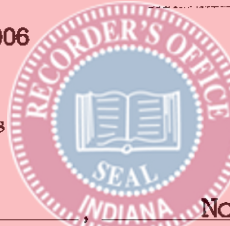
