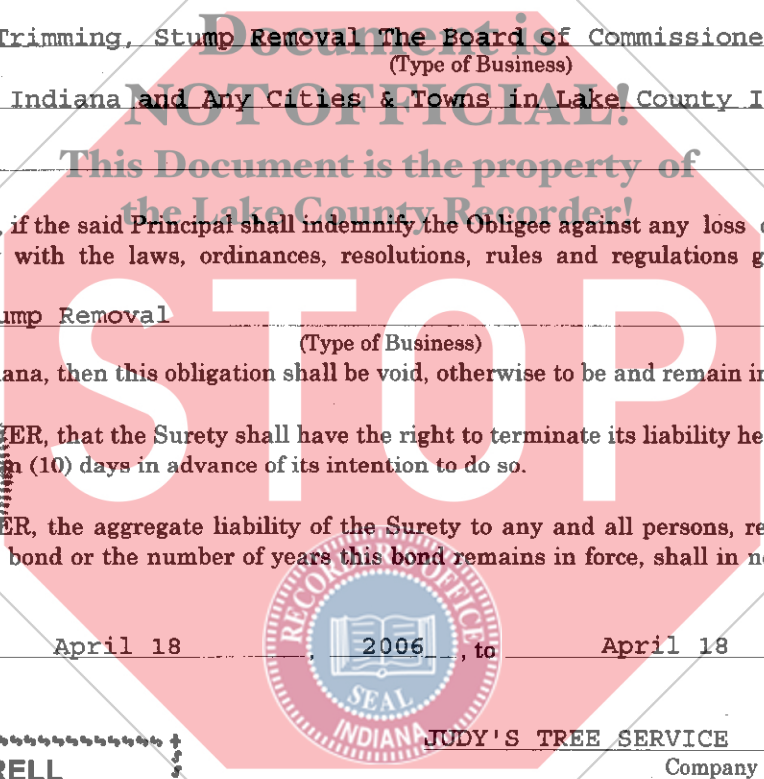
KNOW ALL PERSONS BY THESE PRESENTS, that we, Judy's Tree Service
