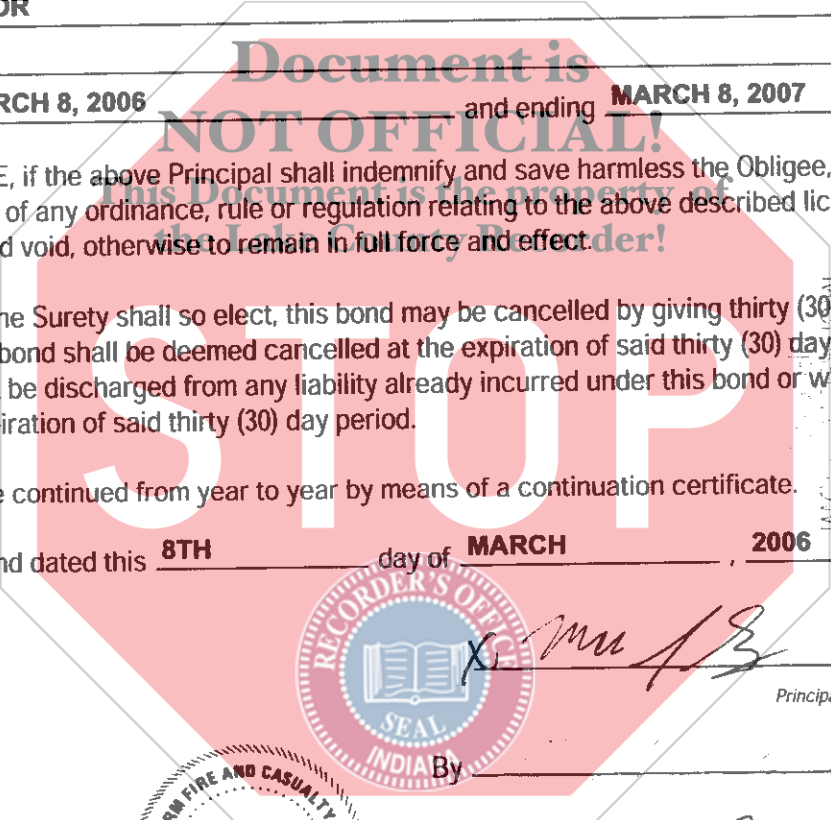
for a term beginning MARCH 8, 2006 and ending MARCH 8, 2007

POWER OF ATTORNEY
