WHEREAS: the above bounden Principal has been granted a

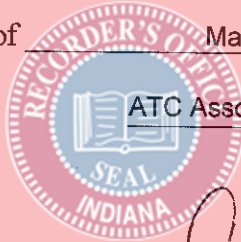
