O'DAY HOLDINGS, a Partnership dated January 1, 2000

of Cook County, in the State of Illinois, for and in consideration of the sum of
TEN AND NO/100-----(\$10.00) Dollars,

the receipt whereof is hereby acknowledged, the following described Real Estate in Lake
County, Indiana, to wit:

The East 273 feet of the following: A part of the Northwest Quarter of Section 25,
Township 37 North, Range 10 West of the 2nd Principal Meridian, being more particularly
described as beginning at a point on the Indiana-Illinois state line, said point being 783-1/2 feet
South of the Northwest corner of said Section 25; thence South 89 degrees 30 minutes East
parallel with the center line of 143rd Street a distance of 435.24 feet, more or less, to a point
which is 128 feet West of the East line of Lot 7, Block 7, now vacated in J. Wm. Eschenburg's
state line addition to Hammond, thence South and parallel with the East line of Lot 7, Block 7,
now vacated and with the center line of the North and South alley in said Block 7, now vacated a
distance of 595.4 feet, more or less, to a point on the North line of 143rd Street; thence West

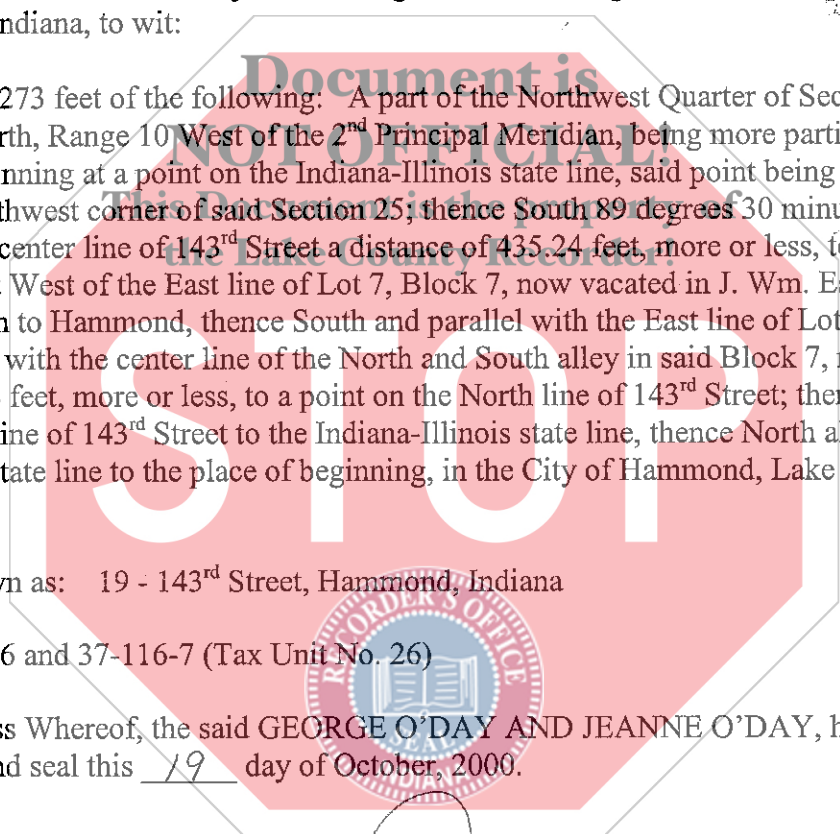




