6. That the following is a full description of all the real property belonging to the decedent:

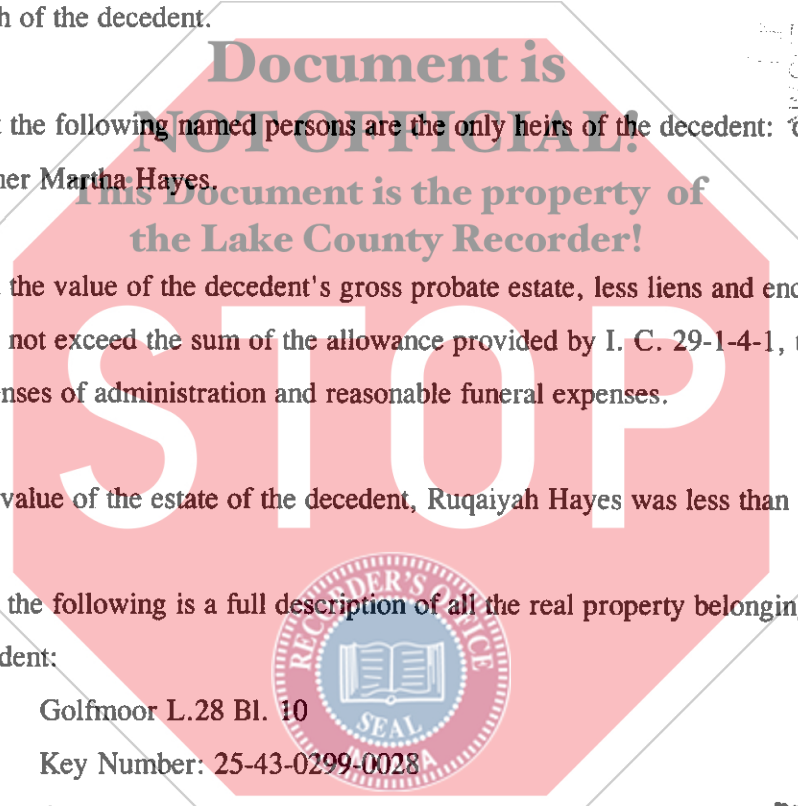
