TAX DEED

WHEREAS JAMES L. 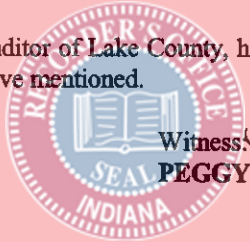
