## **AGREEMENT**

THIS AGREEMENT is entered into between AHEPA 78 Phase V, Inc., (OWNER) and the Secretary of Housing and Urban Development (LENDER) to amend the Mortgage Note given by Owner to Lender on the 3<sup>rd</sup> day of January, 2005 in the amount of \$4,153,900 which was secured by a mortgage of even date which was recorded on the 6th day of January, 2005 in the Office of the Recorder of Lake County, Indiana as Instrument No. 2005-1036 as follows:

(1) The face amount of the Note and Mortgage is amended to read, \$4,144,400 and, All other terms of the Note and Mortgage remain the same.

Nothing in this Agreement shall waive, compromise, impair or prejudice any right the exerctary of HUD shall have to seek judicial recourse for any breach of the Regulatory Agreement that may have occurred prior to or may occur subsequent to the date of this Agreement. In the event that the exerctary of HUD initiates an action for breach of the Regulatory Agreement and recovers funds, either on the secretary's behalf or on behalf of the project or the mortgagor, those funds may be applied, at the discretion of the Secretary of HUD, to payment of the delinquent amounts due under the mortgage or as a partial prepayment of the mortgage debt.
